




METHODIUS CELEBRATIONS AMONG THE SLAVS

This year marks the 1100th anniversary of the death of St. Methodius, the brother of St. Cyril. The two holy brothers are the Apostles of Slavs; to several Slavic nations they brought Christianity and gave them an alphabet.


The Slavic cultures and religious life were profoundly affected by immense contributions of Cyril and Methodius. As Cyril died already in 869, Methodius and disciples continued the work. They introduced the Old Slavonic language into the holy liturgy. At the time of his death Methodius was Archbishop at Mitrovica (north-east Croatia). Methodius like his brother was instrumental in establishing a Slavic Christian literary culture which used the Glagolitic alphabet. The alphabet was especially embraced by the Croatians. The Cyrillic alphabet was probably invented by an earlier Cyril.

This year the Slavs in several European countries, and in diaspora, are paying tribute to Methodius by commemorating the 1100th anniversary of his death in various scholarly, religious, and other gatherings, symposia, lectures, and publications. Pope John Paul II has proclaimed the Holy Brothers Co-patrons of Europe thus giving them due credit for their contribution to all Slavic nations and the rest of Europe.



The Conference of Bishops of Yugoslavia (whose head is the Archbishop of Zagreb, Franjo Cardinal Kuharić) held for the occasion a special "Sabor" attended by representatives of all major religious denominations in SFRY. Among foreign guests in Djakovo were religious dignitaries from: England, Poland, Italy, France, Germany, Austria, Greece, Bulgaria, and Rumania.

On the occasion of the XIth centenary of the death of Saint Methodius the Congress proposes to address itself to the problematic opened to philological, historical and religious research by the mission of the saintly brothers who were the evangelists and teachers of the Slavic peoples.

An ample and free examination and comparison of the results achieved in all countries by modern studies on Cyril and Methodius is directed at illustrating and completing a unitary vision of a moment which was determinative for the formation of Europe.

The Congress is open to all students interested in the subject and it solicits the collaboration of all those specialists in the matter who wish to contribute a communication which fits into the themes the Congress will take up.

The title of the communication and a summary on two typewritten sheets should reach the Secretary of the Congress by 30 April 1985, if they are to be accepted by the Scientific Committee. The final version of the communications will be published in the Acts, provided that the Scientific Committee has given its approval.

The number of communications which can be read (10 min.) or only presented will be determined by the number of communications which are submitted and by the amount of time available.

The Secretary's office is at the disposition of all those seeking information of any type about the Congress, including that which relates to housing.

The reports and communications will be given, in the languages commonly used in international gatherings.

The definitive programme will contain the complete list of reports, the authors and titles of the communications and the schedule for the days of the Congress.

The registration fee is 20,000 Lire Italian (\$ 15.00 USA).

Minutes of the Seventh Annual Business Meeting of the Association for Croatian Studies, Inc.

Time: Saturday, November 3, 1984, 8:15-10:15 a.m.

Place: Room 528, Vista International Hotel, New York City.

During the Sixteenth National Convention of the American Association for the Advancement of Slavic Studies.

(The longer and more detailed version of these Minutes is in our Book of Records.)

President Joseph T. Bombelles opens the meeting at 8:30. Present are 12 members. 2 guests. and there are 5 proxies.

This is followed by suggestions and acceptance of the final Agenda, as well as acknowledgement of proxies.

Secretary-Treasurer reads the Minutes of the last meeting which was held on October 23, 1983 in Kansas City, Mo. In connection with these minutes the question of the Croatian language at the Voice of America is raised again.

There follow the reports by the President and Secretary-Treasurer on past year's activities. At this time (Nov. 3, 1984) we still didn't have our tax exemption from the IRS.

On October 30, 1984 we had 97 members.

Our <u>Announcement</u> No. 9 was published in 200 copies and distributed to all members, prospective members, and various organizations.

Our participation at the Fifteenth AAASS National Convention, held during October 22-25, 1983 at Radisson-Muhlenbach Hotel in Kansas City, Mo. was quite satisfactory. There we sponsored a panel session on Juraj Križanić and one panel dealing with Ivan Meštrović. We also held a roundtable on Križanić.

The state of our Treasury is quite satisfactory.

For the Sixteenth AAASS National Convention in NYC we prepared:

- 1) panel entitled "The Croatian Language in the Context of History and Culture", chaired by George C. Yerkovich, with four papers.
- 2) A Roundtable with the topic "The Present Status and/or Literary Croatian Language" organized and chaired by Anthony Mlikotin.

 There are nine speakers at this session.

3) A panel, organized and chaired by Joseph T. Bombelles, entitled

our Bulletin No. 10.) The report of the Secretary-Treasurer was unanimously accepted.

Following this was a discussion regarding our participation

at the Third World Congress for Soviet and East European Studies

in 1985 (Washington, D. C.), a very important gathering of scholars.

We discussed topics for possible panels. After a ten-minute break we hold elections for a new Executive Committee. Elected were: J. T. Bombelles as President:

Vinko Grubišić and Ante Kadić as Vice-Presidents; and G. J. Prpić as Secretary-Treasurer. Then President Bombelles commemorates two of our members who

passed away recently: Anthony Miletich and Stephen Krešić. The sudden and premature death of both presents a loss to the ACS and to the Croatian community in Canada and America.

Next on the agenda is a lengthy discussion of the status of the Croatian language on this continent. All members participate in this debate. Some suggest: instead of talking so much about this vital issue something should be done about it. One step could be a subcommittee on Croatian language in the ACS. It is pointed out

that HIŠAK (Croatian Schools in Canada and America) sponsors courses for 9700 students in learning of Croatian language, literature and culture.

It is therefore decided that committees for Croatian Language be established in Canada (Krasić and Grubišić) and the United States

(March and Mlikotin). Various proposals are submitted regarding our participation

at the 18th National Convention of the AAASS in New Orleans in 1986. V. Grubišić suggests a panel on Croatian theatre after World War II. M. Petrovich proposes a panel dealing with Croatian Human-

ists and Renaissance. J. Božičević suggests the topic of Croatian Military Frontier. Lj. Krasić would like a panel on "Croatian Folk Arts in North America."

It is agreed that Prof. Petrovich would organize a panel on Croatian Humanists to be held at the New Orleans AAASS Convention.

Other panels (possibly one on Croatian language and culture) will be discussed and one chosen. As an affiliate of the AAASS we may sponsor two panels while our members may organize additional panels sponsored by the AAASS.

For our activities and presence in New Orleans we should contact our member in that city Prof. Milosh Vujnovich.


There being no further business the meeting is adjourned at 10:05.

The Congress is sponsored jointly by the International Committee for Soviet and East European Studies (located in Europe) and our own American Association for the Advancement of Slavic Studies which is the host.

This Third World Congress follows those held in Banff, Canada (1974) and Garmisch, W. Germany (1980). The purpose of this congress is to provide and expand opportunities for the exchange of information throughout the international community of scholars concerned with Soviet and East European Studies.

The Congress will serve as a forum for the presentation of recent research findings and for discussion of scholarly topics. It will seek to promote the advancement of knowledge in the Soviet and East European field by encouraging interdisciplinary and comparative studies as well as work within the scientific academic disciplines.

In charge of the Program Committee, which did enormous work preparing the sessions, is Professor Donald W. Treadgold, School of International Studies, University of Washington, Seattle, Wash 98195. Phone (in case still somebody needs him): (206) 543-1566. It was through Prof. Treadgold that the Association for Croatian Studies prepared its two panel sessions for the Congress. We owe him a great deal of gratitude for his patience, kindness, understanding, and advice.


Our member Jure Kristo will lecture at a panel "The Catholic Church in Yugoslavia" held on the very first day of the Congress, Thursday, October 31 during 9:00-11:30 a.m. Lecturers here include: Chris Cviic, Stella Alexander, and Z. Antič.

Judging from the Preliminary Program, Croatian subjects will be well represented at this international congress. Four panels deal exclusively with the topics from the field of Croatian Studies. There never was so much discussion of Croatia and Croatians at any other Slavic convention in the past.

Everyone attending sessions has to be registered for this congress. To avoid long lines at the registration desk and to save \$10 it is highly recommended that all ACS members pre-register as soon as possible through the AAASS. The address is at the beginning of this article. The AAASS Newsletter of March 1985 has the form for pre-registration. Registration fee for AAASS members is \$40.00 (\$20 for students and retired). The banquet ticket: \$30; excursion tickets at \$7 each.

Last time we met in Washington was three years ago. There were over 2500 people registered at the AAASS Convention. This time there will be at least that many people in attendance. In 1982 close to forty Croatians attended the convention. We hope that this year many of our members and countrymen will join us. There will be an exhibit of Croatian books during six days of the Congress. The CSAC has reserved two booths for this purpose. As we did in the past we would like to meet at a Croatian supper and get-together. There is a possibility that such an event will take place at the Croatian Cultural Center on Monroe St., N. E. We will inform all present at Sheraton about this event. Washington is also an expensive city as we learned in the past.

We urge all who can to come inspite of expenses. This is a unique opportunity to meet scholars from around the world, our countrymen from Europe and this continent.





Catholic Church in Croatia Symposium (in Chicago)

On the Febr. 9. 985. Loyola University hosted a symposium deating with a changing Catholic Church in Croatia. This event was sponsored by newly established organization "Culturlink" and various other cuttural, religious, and ethnic Croatian-American organizations in Chicago area.

The twofold purpose of this conference was first to honor Cardinal Stepinac on the 25th anniversary of his death, and secondly to present various aspects of the developments, problems and perpectives confronting the Catholic Church in Croatia, and to provide and academic forum for a relevant discussion.

Of the three afternoon session the first one dealt with the political and religious ideas of sishop J. 3trossmayer. Dr. Ivo Sivric, the author of the book on Stossmayer, presented his scholary paper in which he expaunded on the misconception that Strossmayer was the ideological "father" of today's Yugoslavia. On the contrary, according to Dr. Sivric, Strossmayer advocated the Croatian soverneighty within the Austro-Hungarian monarch as a buffer against strong Germany and the encrouchment of vast Russia.

The second session concentrated on the biographical research done by author Stella Alexander on the life of Card. Stepinac. Although the british author was not present due to an unfortunate accident, permission was grante to present her paper. The thrust of her paper centers around a triple myth surrounding Cardinal's life. According to the author's thesis only the Catholic "Myth" can be substantiated. In an accademic discussion those present jound that other myths (orthodox and communist) were not dealt sufficiently. In addition, it was decided that a letter with our reply



should be sent to Mrs. Alexender enumerating on certain areas lacking in the biografical study, i.e. historical context, socio-political complexities, lack of historical references, etc. It is hoped that


Alexander will heed our criticism and incorporate it in her apcoming book on Card. Stepinac.

Dr. Jure Kristo presented his paper in the last part of this conference on the subject of "A Marxist Criticism of Croatian Catholicism" His analysis proved to be an excellent Countercriticism of Harxist claims that the Catholic Church in Croatia today is an authoritarian and archaic institution. In conclusion and keeping with the theme of the

the participants were in aggreement with Dr. Kristo's closing remarks that Cardinal Stepinac will remain a reconciliatory force and a unifying symbol of differnet conflicts confronting the Catholic Chur in Croatia.



ST. NICHOLAS CROATIAN CATHOLIC Church on North Side Pittsburgh, PA, the first Croatian church in America, recently celebrated its 90th Anniversary with a Tamburitza Mass, played by the popular Trubaduri of Pittsburgh and sung by the men's church choir and a banquet in the church hall.

The 90th anniversary of the first Croatian church in America St. Nicholas in N. S. Pittsburgh was commemorated on December 2, 1984.

The beginnings of the Croatian parishes coincide with the estab-

lishment of the first fraternal lodges of the Croatian Union, later known as National Croatian Society - the parent organization of the Croatian Fraternal Union. The CFU celebrated last year its 90th anniversary.

The above illustration is from the <u>Zajedničar</u>, the weekly organ of the CFU, now in its 80th year of existence. It is printed in tabloid format in English and Croatian. It is excellently edited, a veritable chronicle of Croatian life in America and Canada. It is also the largest Croatian newspaper in America and abroad.



The Association for Croatian Studies, Inc. (The ACS)

The ACS was founded on October 15, 1977, during the Ninth National Convention of the American Association for the Advancement of Slavic Studies at Capital Hilton Hotel, Washington, D.C.

It became an affiliate of the AAASS on October 15, 1978 during the Tenth AAASS National Convention at the Neil House Hotel, Columbus, Oh.

According to Article 2 of the Constitution and By-Laws:

The ACS is a nonprofit, nonpolitical and professional organization whose purpose is to advance scholarly study, publication and teaching relating to Croatia and the Croatians. The ACS will foster closer communication among scholars interested in Croatian Studies.

On June 8, 1983 the ACS was incorporated in the State of Ohio. On November 14, 1984 it received the Federal tax exemption. By the end of 1984 the membership was 100.

The ACS sponsored panel and roundtable sessions at the National Conventions of the AASS in: Columbus, Ohio (1978); New Haven, Conn. (1979); Philadelphia, Pa. (1980); Asilomar-Monterey, Cal. (1981); Washington, D.C. (1982); Kansas City, Mo. (1983), and New York City (1984). It will participate at the III World Congress of Slavists in Washington in November 1985. Participants in our sessions are

scholars from the United States, Canada and Europe. The main function of the ACS is to organize and sponsor sessions at the AAASS conventions and other meetings dealing with Slavic Studies.

Nine issues of the Announcement (averaging 20 pp.) have been published. Under the new name, The Bulletin of the ACS was printed in Dec. 1984. With issue No. 10 it became a semi-annual publication. Membership dues: \$10.00 a year; student membership is \$3.00 a year.





DEATH CLAIMS FOUR MEMBERS OF THE A.C.S.

It is our sad duty to report the passing away of four our members: Dinko Šuljak, Silvije Grubišić, Stanko Borić, and Vladimir J. Bosiljević.

Dr. Dinko Suljak died on January 17, 1985 in Davis, Calif. on the eve of his 70th birthday. He was born on January 17, 1915 near Zadar, Dalmatia. After graduating from the Classical Gymnasium he studied at the Faculty of Jurisprudence, University of Zagreb where he received his diploma in 1940. In 1946 he obtained his J. D. at the University of Rome. In 1964 he earned his M.A. in the Library Science, University of Chicago.

For many years he was the head librarian at the Univ. of California in Davis. In his early years of life in the U.S. he was the editor (during 1950-1952) of the American Croatian Herald in Chicago. He published many articles and studies in his professional field as well as in the area of modern Croatian history. He is the author of Croatian's Struggle for Independence; A Documentary History (Arcadia, Cal.: Croatian information Service, 1977), 388 pp. Before he died he was finishing the manuscript on his life and involvement in the Croatian Peasant Party and related aspects of recent Croatian political development. The book was supposed to be published by Hrvatska Revija in Barcelona. To his widow Estelle (nee Lasic) we extend our sincere sympathy.



Rev. Silvije Grubišić, OFM

Died in West Allis, Wis. on May 12, 1985. He was born in Sovici Herzegovina on April 8, 1910. He attended the well known Franciscan Gymnasium at Siroki Brijeg, joined the Franciscan Order in August 1929, and was ordained as priest in June 1935. He finished his theological studies in Sargiano, Italy in 1936. He immigrated to America in June 1938, and subsequently worked at several Croatian Franciscan parishes as assistant and pastor.

He was a solid scholar, a very good writer, and editor. In 1944 he started - and edited for seven years - the Croatian Catholic Messenger and issued the first issues of the Croatian Almanac. These two publications are still in existence. As a

tireless researcher ha travelled to Palestine, Iran and Afghanistan because he was deeply involved in biblical studies and in the Iranian origin of the Croatian people. In 1968 he published in New York Pripovijest o Bibliji: s puta po biblijskim zemljama. In 1979 he published


Od Pradomovine do Domovine where he traced the Croatian name engraved in ancient Persia in 520 B.C. On the same subject he also wrote: 2500 godina hrvatskog imena i državnosti (Hamilton, Ontario, 1981).

His life work is the publication in Croatian language of all books of the Old Testament. He finished several books of the New Testament. His Croatian language is flawless, original and beautiful. His excellent style and rich Croatian are evident in many of his articles scattered during several decades in Croatian newspapers and periodicals. He excelled in all his activities: as a priest and spiritual leader, a writer, theologian, biblical scholar, linguist, translator, archaeologist, historian, and patriot.

Vladimir Josip Bosiljević

known by thousands of Americans and Croatians. He was born on March 2, 1908 in Glina, Croatia. He graduated from the Classical Gymnasium in Zagreb and later received his diploma of engineering in forestry at the University of Zagreb in 1931. During the war years he was in Croatian diplomatic service; after May 1945 he founded the Croatian Red Cross to help thousands of Croatian refugees in Austria and Germany. In 1951 he arrived in Cleveland, Ohio joining the influx of the post-W. W. II Croatian immigration to this country. He founded the Society for Croatian Migration and sponsored the immigration of more than five thousand of his countrymen to the U.S. He became very active in the Croatian Academy of America and served for many years as administrator of Croatia Press. A tireless and restless man he was active in many American and Croatian organizations and societies. He got also involved in the Nationalities Movement sponsored by the Republican Party. represented the Croatians and was received several times in the White House. He supported wherever he could by word, deed, money, and influence the social, cultural, religious, and political advancement of his people. He is survived by his wife lvka, three daughters, a son and eight grandchildren. To all of them we extend our sympathy.



Stanko (Stanley) Borić died on July 20, 1985 at Crown Point, Indiana. He was born in Brist, Dalmatia on December 5, 1909. He studied Law at the University of Zagreb before coming to America in 1939 as a representative of the organization "Hrvatski Radiša". In 1939 he joined the Croatian Catholic Union where he was active for many years. He and his wife Helen (nee Hranilovic) were editors of Naša Nada - Our Hope, the CCU's organ, from 1950 until 1978. They also established a very successful store for religious articles. He edited and published



the almanac (Kalendar) of the CCU for several years. In 1960 the CCU published his The Croatian Picture Primer (Hrvatska Početnica sa slikama). In 1954 he edited Andrija Kačić Miošić's popular book Hazgovor ugodni. He also edited and published several souvenir books of which one was The Story of Croatian Shrine Marija Bistrica in Washington, D. C. in 1970. He earned his B. A. degree at Calumet College at the age of 71. He was a dedicated and active Catholic layman and Croatian patriot. He leaves behind his wife, five daughters, one son and fourteen grandchildren. To all of them we extend our heart-felt condolences.



JAKOV BAČIĆ Ph. D.

Jakov J. Bačić was born in Karlobag on September 19, 1940; he graduated from Križanić Gymnasium in Zagreb. Upon his arrival as an immigrant in this country he attended Hunter College where he received his B.A. in English Literature. For his subsequent M.A. in Russian Literature at Columbia University he wrote a thesis dealing with "Ethnogenesis

of the People of Bosnia." For years he worked as selfemployed editor and translator. Among his major translations (in excellent English) is Sime Djodan's study

"The Evolution of the Economic System of Yugoslavia and the Economic Position of Croatia" (102 pp. long) that was published in the <u>Journal of Croatian Studies</u>, Vol. XIII, 1972. Djodan's article was one of the major documents written during the time of the "Croatian Spring."

Bačić's special field of study is Slavic civilizations and the early history of Croatia. In October of 1983, our member Jakov Bačić received his Ph. D. at Columbia U. His doctoral dissertation is:

"The Emergence of the Sklabenoi (Slavs), Their Arrival on the Balkan Peninsula, and the Role of the Avars in These Events: Revised Concepts in a New Perspective." 


